RESPONSIBILITY FOR ROAD TRAFFIC VIOLATIONS

Article	Offence	Sanctions / measures to ensure legal proceedings on administrative offences
12.10 part 1	Crossing a railway track outside the railway crossing, entering a railway crossing with a closed crossing gate or against the red traffic light or against the restrictive signal of the employee on duty. Stopping or parking at a railway crossing	Penalty: administrative fine 1000 rubles or driving license suspension for the period from 3 to 6 months
12.11 part 1	Stopping the vehicle on an highway outside special parking aprons	Penalty: administrative fine 1000 rubles
12.11 part 3	U-turning or entering a vehicle into technological gaps of a traffic strip on a highway or backing run on a highway	Penalty: administrative fine 2500 rubles
12.12 part 1	Red lights run or run against the prohibiting gesture of the traffic controller	Penalty: administrative fine 1000 rubles
12.12 part 2	Failure for stopping before the stop line, against the red traffic light or prohibiting gesture of the traffic controller	Penalty: administrative fine 800 rubles
12.13 part 1	Entering an intersection in case of a traffic jam-up that caused the driver to stop, creating an obstacle to the movement of vehicles in cross direction	Penalty: administrative fine 1000 rubles
12.13 part 2	Failure to give way to a vehicle that enjoys the priority right of crossing intersections	Penalty: administrative fine 1000 rubles
12.14 part 1	Failure to give a signal before starting, changing lane, turning, U-turning or stopping	Penalty: warning or administrative fine 500 rubles
12.14 part 1.1	Failure to take in advance the corresponding extreme position on the carriageway intended for movement in the relevant direction before turning to the right, left or U-turning	Penalty: warning or administrative fine 500 rubles
12.14 part 2	U-turning or backing run in places where such maneuvers are prohibited	Penalty: administrative fine 500 rubles
12.14 part 3	Failure to give way to a vehicle that has the priority right of passing	Penalty: warning or administrative fine 500 rubles
12.15 part 1	Location of the vehicle on the roadway, passing of oncoming traffic, as well as driving along the road sides	Penalty: administrative fine 1500 rubles

12.15 part 2	Driving along bicycle paths or pedestrian paths or sidewalks	Penalty: administrative fine 2000 rubles
12.15 part 3	Crossing into a lane intended for oncoming traffic, when bypassing an obstacle, or crossing a tramway of the opposite direction when bypassing an obstacle	Penalty: administrative fine 1000 – 1500 rubles
12.15 part 4	Crossing into a lane intended for oncoming traffic or a tramway of the opposite direction in violation of the Traffic Rules, except for the cases provided for by part 3 hereof	Penalty: administrative fine 5000 rubles or driving license suspension for the period from 4 to 6 months
12.16 part 1	Failure to comply with the requirements prescribed by road signs or road markings, except for the cases stipulated by parts 2-7 hereof and other articles of this chapter	Penalty: warning or administrative fine 500 rubles
12.16 part 2	Turning to the left or U-turning in violation of the requirements prescribed by road signs or road marking	Penalty: administrative fine 1000 - 1500 rubles
12.16 part 3	Driving in the opposite direction on a road with one-way traffic	Penalty: administrative fine 5000 rubles or driving license suspension for the period from 4 to 6 months
12.16 part 4	Failure to comply with the requirements prescribed by road signs or road marking, prohibiting the stopping or parking of vehicles, except in the case provided for in part 5 hereof	Penalty: administrative fine 1500 rubles Enforcement measures: Detention of a vehicle with its location at a special parking lot
12.16 part 5	The violation provided for by part 4 of this article, committed in a city of federal status, in Moscow or St. Petersburg	Penalty: administrative fine 3000 rubles Enforcement measures: Detention of a vehicle with its location at a special parking lot
12.17 part 1	Failure to yield to a route vehicle, as well as to a vehicle with simultaneously activated blue rotating warning beacon and a special sound signal	Penalty: warning or administrative fine 500 rubles
12.17 part 1.1	Running along the lane for route vehicles or stopping on the specified lane, except for the cases provided for in parts 3 - 5 of article 12.15 of this Code and the case specified in part 1.2 hereof	Penalty: administrative fine 1500 rubles
12.17 part 1.2	The violation provided for by part 1.1 of this article, committed in a city of federal status, in Moscow or St. Petersburg	Penalty: administrative fine 3000 rubles

12.17 part 2	Failure to yield to a vehicle having special color schemes, inscriptions and marks on the outer surfaces, with simultaneously activated blue rotating warning beacon and a special sound signal	Penalty: administrative fine 500 rubles or driving license suspension for the period from 1 to 3 months
12.18	Failure to give way to pedestrians or cyclists, who have the priority right of movement	Penalty: administrative fine 1500 - 2500 rubles
12.19 part 2	Violations of rules of stop or parking of vehicles in the places allocated for stop or parking of vehicles of handicapped	Penalty: incurs the imposition of an administrative fine to the driver 5000 rubles Enforcement measures: Detention of a vehicle with its location at a special parking lot
12.19 part 3	Stop or parking of vehicles at a pedestrian crossing and closer than 5 meters in front of it or violation of the rules of stop or parking of vehicles on the sidewalk	Penalty: administrative fine 1000 rubles Enforcement measures: Detention of a vehicle with its location at a special parking lot
12.19 part 3.1	Stop or parking of vehicles in the places of stopping of route vehicles or parking of passenger taxi or closer than 15 meters from these places, except for a stop for boarding or disembarking passengers	Penalty: administrative fine in the amount of one thousand rubles Enforcement measures: Detention of a vehicle with its location at a special parking lot
12.19 part 3.2	Stop or parking of vehicles on tramways or stop or parking of vehicles further than the first row from the edge of the traffic way	Penalty: administrative fine 1500 rubles Enforcement measures: Detention of a vehicle with its location at a special parking lot
12.19 part 4	Violation of the rules of stop or parking of vehicles on the traffic way, which caused obstacles to the movement of other vehicles, as well as stop or parking of a vehicle in a tunnel	Penalty: administrative fine 2000 rubles Enforcement measures: Detention of a vehicle with its location at a special parking lot
12.19 part 5	The violation provided for by part 1 of this article, committed in a city of federal status, in Moscow or St. Petersburg	Penalty: administrative fine 2500 rubles

12.19 part 6	The violations provided for by parts 3-4 of this article, committed in a city of federal status, in Moscow or St. Petersburg	<p>Penalty: administrative 3000 rubles</p> <p>Enforcement measures: Detention of a vehicle with its location at a special parking lot</p>
12.20	Violation of the rules for the use of external lights, sound signals, alarm signaling or emergency road triangle	<p>Penalty: warning or administrative fine 500 rubles</p>
12.21 part 1	Violation of cargo transportation rules and towing rules	<p>Penalty: warning or administrative 500 rubles</p>
12.23 part 3	Violation of requirements for transportation of children	<p>Penalty: administrative fine 3000</p>
12.24 part 1	Violation of Traffic Rules or rules for vehicles operation that led to minor harm to health of the injured person	<p>Penalty: administrative fine 2500 – 5000 rubles or driving license suspension for the period from 1 year to 1,5 year</p> <p>Enforcement measures: alcohol testing</p>
12.24 part 2	Violation of the Traffic Rules or rules for vehicles operation that led to moderate severe harm to health of the injured person	<p>Penalty: administrative fine 10000-25000 rubles or driving license suspension for the period from a 1,5 to 2 years</p> <p>Enforcement measures: alcohol testing</p>
12.25 part 2	Failure to fulfill a legal requirement of a police officer to stop a vehicle	<p>Penalty: administrative fine 500 to 800 rubles</p>
12.26 part 1	Vehicle driver's failure to fulfill a legal requirement of an authorized official to undergo medical examination for alcohol intoxication	<p>Penalty: administrative fine 30000 rubles and driving license suspension for the period from a 1,5 to 2 years</p>

		Enforcement measures: detention of a vehicle with its location at a special parking lot, ban to drive a vehicle and examination for alcohol intoxication
12.26 part 2	Vehicle driver's, banned to drive a vehicle or with suspended driving license, failure to fulfill a legal requirement of an authorized official to undergo medical examination for alcohol intoxication if such actions (inaction) do not include criminal offense	Penalty: administrative arrest for a period from 10 to 15 days or administrative fine 30000 rubles for people in relation to whom administrative arrest cannot be applied Enforcement measures: detention of a vehicle with its location at a special parking lot, ban to drive a vehicle and examination for alcohol intoxication
12.27 part 1	Driver's failure to turn on the alarm, set an emergency stop sign, release the roadway (if there are no casualties) in connection with road accident in which he/she was involved with the exclusion of cases stipulated in part 2 of this article	Penalty: administrative fine 1000 rubles
12.27 part 2	Leaving the place of a road accident by a driver he/she was involved in, except when there is no need for paperwork, or the police officer specifies the place where it is necessary to arrive for their registration	Penalty: driving license suspension for the period from 1 year to a 1,5 or administrative arrest for the period up to 15 days
12.28 part 1	Non-priority for pedestrians, parking with engine running	Penalty: administrative fine 1500 rubles
12.28 part 2	The violation provided for by part 1 of this article, committed in a city of federal status, in Moscow or St. Petersburg	Penalty: administrative fine 3000 rubles
12.29 part 1	Violation of the Traffic Rules by a pedestrian or a passenger of a vehicle	Penalty: warning or administrative fine 500 rubles
12.29 part 2	Violation of the Traffic Rules by a person riding a bicycle	Penalty: administrative fine 800 rubles

12.29 part 3	Violation of the Traffic Rules by persons riding a bicycle in the state of alcohol intoxication	Penalty: administrative fine 1000 - 1500 rubles
12.2 part 1	Driving of a vehicle with non-legible, non-standard or installed in violation of state standard requirements license plates	Penalty: warning or administrative fine 500 rubles
12.2 part 2	Driving a vehicle without license plate, as well as with license plates preventing from identification or providing the possibility to alter or hide them	Penalty: administrative fine 5000 rubles or driving license suspension for the period from 1 to 3 months
12.2 part 4	Driving a vehicle with consciously forged license plates	Penalty: driving license suspension for the period from 6 months to 1 year
12.30 part 1	Violation of the Traffic Rules by a pedestrian, a passenger of a vehicle or other participant of traffic that led to traffic hindrance	Penalty: administrative fine 1000 rubles
12.30 part 2	Violation of the Traffic Rules by a pedestrian, a passenger of a vehicle or other participant of traffic that out of negligence led to minor or moderate severe harm to health of the injured person	Penalty: administrative fine 1000 - 1500 rubles
12.36.1	Using by a driver, while driving a vehicle, of a telephone set which is not equipped with a technical device "hands free"	Penalty: administrative fine 1500 rubles
12.37 part 2	Failure of a vehicle's owner to discharge his (her) duty concerning insurance of his (her) civil liability as well as driving a vehicle where such compulsory insurance is designedly absent	Penalty: administrative fine 800 rubles
12.3 part 1	Driving a vehicle without the registration documents relating to the vehicle.	Penalty: warning or administrative fine 500 rubles Enforcement measures: detention of a vehicle with its location at a special parking lot, ban to drive a vehicle
12.3 part 2	Driving a vehicle by a driver who does not have with him (her) driver license or an insurance of civil liability of vehicle's owners.	Penalty: warning or administrative fine 500 rubles

12.3 part 3	Transfer of control over a vehicle to a driver who does not have with him (her) documents entitling him (her) to drive a vehicle	Penalty: administrative fine 3000 rubles
12.5 part 1	Driving a vehicle with defects or under conditions when operation of the vehicle is prohibited	Penalty: warning or administrative fine 500 rubles
12.5 part 2	Driving a vehicle having brakes (except for a parking brake), a steering system or a hitch mechanism (when a vehicle is part of a train) which are known to be out of order	Penalty: administrative fine 500 rubles Enforcement measures: detention of a vehicle with its location at a special parking lot, ban to drive a vehicle
12.5 part 3	Driving a vehicle with devices with lights other than white, yellow or orange.	Penalty: driving license suspension for the period from 6 months to 1 year with confiscation of the specified instruments and devices
12.5 part 3.1	Driving a vehicle featuring glasses (for instance those coated with transparent color film) light transmittance of which is less than 70%	Penalty: administrative 500 rubles
12.6	Driving a vehicle by a driver whose safety belt is not fastened, or transporting passengers whose safety belts are not fastened as well as driving a motorcycle or a moped, or transporting passengers on a motorcycle without crash helmets or with not fastened crash helmets.	Penalty: administrative fine 1000 rubles
12.7 part 1	Driving a vehicle by a driver who has no right to drive a vehicle.	Penalty: administrative fine 5000 - 15000 rubles Enforcement measures: detention of a vehicle with its location at a special parking lot, ban to drive a vehicle
12.7 part 2	Driving a transport vehicle by a driver disqualified from driving.	Penalty: administrative fine 30000 rubles or administrative arrest for a period from 10 to 15 days or compulsory community service for the period from 100 to 200 hours

		Enforcement measures: detention of a vehicle with its location at a special parking lot, ban to drive a vehicle
12.7 part 3	Transfer of control over a vehicle to a person who is known to have no driving license or who is known to be disqualified from driving.	Penalty: administrative fine 30000 rubles
12.8 part 1	Driving a vehicle by a driver in the state of alcoholic intoxication.	Penalty: administrative fine 30000 rubles and driving license suspension for the period from 1,5 year to 2 years Enforcement measures: detention of a vehicle with its location at a special parking lot, ban to drive a vehicle and examination for alcohol intoxication
12.8 part 2	Transfer of control over a vehicle to a person in the state of alcoholic intoxication.	Penalty: administrative fine 30000 rubles and driving license suspension for the period from 1,5 year to 2 years
12.8 part 3	Driving a vehicle by a driver in the state of alcoholic intoxication, having no driving license or disqualified from driving	Penalty: administrative arrest for a period from 10 to 15 days or administrative fine 30000 rubles Enforcement measures: detention of a vehicle with its location at a special parking lot, ban to drive a vehicle and examination for alcohol intoxication
12.9 part 2	Exceeding the speed limit by more than 20 kilometers per hour, but no more than 40 kilometers per hour	Penalty: administrative fine 500 rubles
12.9 part 3	Exceeding the speed limit by more than 40 kilometers per hour, but no more than 60 kilometers per hour	Penalty: administrative fine 1000 - 1500 rubles
12.9 part 4	Exceeding the speed limit by more than 60 kilometers per hour, but no more than 80 kilometers per hour	Penalty: administrative fine 2000 2500 rubles or driving license

		suspension for the period from 4 to 6 months
12.9 part 5	Exceeding the speed limit by more than 80 kilometers per hour	Penalty: administrative fine 5000 rubles or driving license suspension for the period of 6 months
19.3 part 1	Disobedience to the lawful order or demand of a police officer.	Penalty: administrative fine 500 - 1000 rubles or administrative arrest for up to 15 days
